Tasks and responsibilities

What will you do as Packaging Expert?

In this position you are the packaging expert within the Enteral Nutrition business. The position is within the Quality Control department. The Packaging Expert is responsible for 1 or 2 direct reports and will reports directly to the Manager QC.

As Packaging Expert, you are responsible for assessing compliance declarations for Dutch packaging materials, handling of packaging complaints with suppliers, representing packaging topics in multiple projects, supporting qualification of alternative packaging suppliers, validation of packaging materials, drafting packaging specifications, interfacing with our medical device department and subject matter expert for packaging related problems.

You will closely collaborate with your laboratory coordinator, who oversees daily operation in the laboratory.

Task and responsibilities include:

- Release of packaging materials
- Creation of QC related documentation (analysis reports, SOP's, etc.)
- Provision of laboratory specific KPI's
- Complaint handling, first point of contact with our packaging suppliers
- Participate in validation and qualification activities regarding packaging materials
- Participate in supplier audits
- Responsibility for safety according to existing regulations

You will follow up quality related activities with internal production as well as with contract manufacturers and be in close alignment with other departments such as Quality Assurance, Research & Development, Supply Management and Market Units. You prepare certificates, statements, and statistical evaluations to support analytical and quality related requests.

As the Packaging Expert you are responsible for personnel in your department, their training and ensure safety (EHS) according to existing regulations. You are also responsible for budget control and investment planning for the packaging laboratory.

In short, this is a versatile function in which you take care of all quality control aspects of packaging!
